Program Information

Lending library approval is based on eligibility, availability of books, and available funding. Student must have exhausted all financial aid, be a member of a special population, and return all books and materials borrowed through the lending library at the end of the semester.

Eligibility

Students who meet the following criteria are eligible to submit lending library requests:

- Exhausted all financial aid
- Must be a student currently enrolled in Savannah Technical College
- Must be a member of one (or more) of the special populations listed below:
 - Individual with Disability
 - Out-of-workforce Individual
 - Single Parent including single pregnant women
 - Individual preparing for non-traditional field (according to gender)
 - English Learner
 - Economically Disadvantaged (includes Pell grant and public benefits recipients, low-income adults)
 - Armed Forces/Active Duty Dependent
 - Homeless individuals described in section 725 of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11434a); or unstable residence
 - Foster Care or aged out of foster care
 - Displaced Homemaker
