## **Residency Petition**

PLEASE READ THE FOLLOWING INFORMATION CAREFULLY BEFORE SUBMITTING THIS PETITION TO THE STUDENT AFFAIRS OFFICE. Return to STC Student Affairs upon completion.

PLEASE NOTE: Legal residence requires not only recent physical presence in Georgia, but also the element of intent to reside here indefinitely. Appropriate documentation must be submitted with this form and must reflect at least 12 consecutive months of Georgia residency immediately proceeding the first day of classes of the term for which you are seeking the in-state rate. Please refer to the "Required Residency Documentation" information on the back of this form. **This form is NOT for Financial Aid purposes.** 

If a change in residency is approved, the new classification shall become effective\* the beginning of the following semester. Petitions will not be processed after the last day for drop and add period.
